





EXHIBITOR/SPONSOR SUPPORT AGREEMENT RULES& REGULATIONS

1. Agreement to Terms

By submitting an exhibitor or sponsor application and submitting payment, the applicant and its representatives agree to comply with the following rules and regulations as set forth by The Stem Cell Conference (hereafter "SCC"). SCC reserves the right to amend or enforce these terms to ensure a professional and safe environment for all attendees and partners.

2. Booth Assignments

Exhibit space will be allocated by SCC on a first-come, first-served basis. Placement will consider sponsorship level, date of agreement, and booth package selection. SCC reserves the right to reassign booth locations or modify the exhibit floor plan as needed.

3. Booth Package Inclusions

Each 10ft x 4ft booth includes:

- Pipe-and-drape with black back and side walls
- One 6ft table, two chairs
- Standard power outlet and Wi-Fi
- 2 complimentary exhibitor personnel badges
- 2 all-access passes (includes meals and lectures)
- Company listing in the conference app and website
- Lead capture services
- Invitations to elite networking events (Welcome Reception & Gala)

4. Exhibitor Badges

Each exhibiting company will receive two (2) exhibitor badges. Additional badges may be purchased. Badges are non-transferable and misuse (e.g., badge sharing or falsification) will result in removal from the event and possible ban from future SCC events.

5. Booth Design Guidelines

Booth designs may not interfere with adjacent exhibits or aisles. Maximum permitted height is 8 feet for the back wall and 4 feet for side dividers. All exposed areas must be finished. Custom booth builds that deviate from standard specs must receive prior written approval from SCC.

6. Move-In / Move-Out

- Move-In: Wednesday, June 3, 2026 (10:00 AM 7:00 PM)
- Move-Out: Saturday, June 6, 2026 (2:30 PM 4:00 PM)

Early breakdown is strictly prohibited and may impact future participation eligibility.

7. Exhibit Hours

Exhibitors are expected to staff their booths during all exhibit hall hours, networking breaks, and scheduled meal functions. Full exhibitor schedule will be provided in advance.

8. Unused Space

SCC reserves the right to reassign any booth space left unoccupied one hour after the exhibit hall opens without a refund.

9. Payment Terms


Full payment is due upon submission of the signed Exhibitor/Sponsor Agreement. Booths are not guaranteed until payment is received. Failure to pay may result in forfeiture of exhibit space.

10. Cancellation Policy

- Written cancellations received on or before February 15, 2026 are eligible for a 50% refund.
- Cancellations after February 15, 2026 are non-refundable, and full payment remains due.
- Sponsorships are non-refundable once confirmed. If the event is rescheduled or relocated, all signed agreements will automatically transfer to the new date/location.

11. Food & Beverage

All food and beverages served in booth areas must be arranged through the Wynn Las Vegas catering services. No outside food or drink is permitted without venue approval.

EXHIBITOR/SPONSOR SUPPORT AGREEMENT RULES & REGULATIONS CONTINUED

12. Sound & Noise Control

Exhibitors must maintain reasonable sound levels to avoid disruption. SCC staff reserves the right to intervene or restrict audio/video use that negatively impacts surrounding booths.

13. Security & Insurance

General event security will be provided during off-hours. However, SCC, The Mark Society, and Wynn Las Vegas are not liable for lost, stolen, or damaged property. Exhibitors are encouraged to maintain insurance coverage and may be asked to submit proof of insurance upon request.

14. Fire & Safety Regulations

All exhibit materials must comply with fire codes. Open flames, hazardous substances, or blocked fire exits are strictly prohibited. Venue safety inspections may be conducted, and violations will be addressed immediately.

15. Property Damage

Exhibitors are financially responsible for any damage caused to the venue, other exhibitors' booths, or show property. Nothing may be affixed to walls, floors, or ceilings without prior approval.

16. Professional Conduct

All booth personnel are expected to maintain a professional demeanor at all times. Offensive behavior, harassment, or aggressive sales tactics may result in removal from the event.

17. Promotional Materials & Demos

Distribution of brochures, samples, and other materials must be confined to the exhibitor's assigned booth space unless otherwise approved. Demonstrations must not disrupt neighboring booths.

19. Access to Exhibit Hall

Exhibit hall access is restricted to registered exhibitors and attendees. No children under the age of 18 are allowed in the hall during set-up, event hours, or teardown.

20. Sponsorship Conduct

Sponsors are expected to uphold the integrity of SCC's mission. Sponsorship benefits may not be transferred or resold. SCC reserves the right to revoke benefits if misuse occurs.

21. Exhibitor Events & Meetings

Any exhibitor-hosted meetings or social functions must not conflict with SCC programming. Approval is required for any such activities during the conference dates.

22. Medical Devices & Demonstrations

All device demonstrations, including lasers and other medical technologies, must follow industry safety standards. Protective eyewear and enclosures may be required. Devices must not pose any risk to attendees or personnel.

23. Indemnification

Exhibitor agrees to indemnify and hold harmless SCC, The Mark Society, and the Wynn Las Vegas from and against any claims, liabilities, damages, or costs arising from their participation in the event, including but not limited to property damage, injury, or legal disputes.

24. Governing Law

This agreement shall be governed by the laws of the State of Florida. Any disputes shall be resolved in courts located in Broward County, Florida.
